75/08 Sergeant Warner advised members on the crime figures for April, which
 showed an increase of criminal damage and dwelling house burglaries.
- Councillor Mrs M Arnold referred specifically to a recent incident involving
a dwelling house burglary and attempts made by the South Wales Police to
apprehend the offenders with the use of the police helicopter. Councillor Mrs
Arnold was concerned that this involved it flying above her property at such a
height that she perceived it might cause damage to her aerial. Councillor Mrs
Arnold also complained about the noise that the helicopter made and the
number of police that were involved trying to apprehend the offenders.
Sergeant Warner assured Councillor Mrs Arnold that the police helicopter is
not allowed to fly below a certain height, approximately 300 feet and one of
the quietest of its type. Only three officers were involved ‘on the ground’
during the operation.
Councillor J R Harris and Councillor Mrs G Baty both pointed out that the
Town Council fully supported the police in any actions they took in trying to
apprehend criminals in the area and were grateful that the resource of the
police helicopter was used in this incident.
