- Item 4:** **To confirm the minutes of the Town Council Meeting held on**

- Item 5:** **Matters arising from Town Council Meeting held on**
33/06 **21st February 2006.**
Councillor J R Harris referred to Item 8b in relation to the renewal of the membership for One Voice Wales, which was deferred from the last meeting pending information from the Town Council representative, Councillor Mrs S M Cox.
Councillor Mrs S M Cox advised that she considered that it is worthwhile for the Town Council to continue its membership and that the staffing issues within the organisation are being addressed.
Proposed by Councillor Mrs S M Cox, seconded by Councillor J R Harris, that the Town Council continues membership of One Voice Wales and the subscription renewal of £412 is paid.

- Item 6:** **Community Police Matters.**
34/06 Inspector Patterson circulated figures for the month of February and gave a breakdown of some the crimes reported. The assault and public order offences arose out of a single incident after the England v Wales rugby international. The theft from motor vehicles involved removal of Satellite Navigation systems. Out of the 20 reported crimes, 12 have been detected and the crime rate in the Vale is 7.8% down compared to the same period last year.

Councillor J R Harris referred to an item discussed at the Community Liaison Committee Meeting on 15th March in respect of a new police initiative called 'PACT'. Inspector Patterson gave a brief outline of what will be taking place and how panels will be set up by the police before whom members of public can voice their concerns. The aim is then for the panels to select the most important problems raised with a view to solving them.
- Item 7:** **Road Safety.**
35/06 Inspector Patterson introduced Acting Sergeant Mark Allen who had been looking at various road safety issues, which were raised by this Council.
- Parking bay at the junction of Westgate and Llantwit Major Road – A report has been submitted to the Traffic Management Department and the Vale of Glamorgan Council regarding the dangers of the bay. A survey of the parking bay is to be carried out.
 - Builders skip in the double-parking bay outside Bar 44 – Acting Sergeant Allen confirmed that the skip is not sited in the disabled parking area of the bay.

Item 7: **Road Safety. (Continued)**
Councillor G A Cox did not take part in the debate on the following resolution.

7.1 Resolution moved by Councillor L E Taylor in respect of Traffic Congestion in Westgate.

“Recognising that the follow of traffic along Westgate is impeded every weekday between its junction with the High Street and the vicinity of the Police Station, the Town Council request the Vale of Glamorgan Council to initiate the statutory procedures necessary in order to prohibit parking on the North side of Westgate between Eagle Lane and Ramoth Church from 8.00 to 18.00 on weekdays”.

The resolution was not moved.

Proposed by Councillor H Ll Morgan, seconded by Councillor Mrs L Adams, that the pavement is narrowed on the South Side of Westgate between Eagle Lane and the Police Station in order to widen the carriageway for all vehicles and to prevent any reduction of on-street parking on the North Side of Westgate.

Resolved as proposed.

Councillor Mrs G Baty advised Inspector Patterson that bus drivers attempting to park in the bus bay are experiencing problems as a result of the limousines and other vehicles being parked on the site and causing an obstruction. Inspector Patterson recommended that the bus drivers should telephone the police at the time of these incidents to allow the police to respond, subject to their availability, and take appropriate action.

Councillor Mrs G Baty advised that she had received a letter from the Vale of Glamorgan Council regarding a proposed Traffic Regulation Order to extend the prohibited waiting at any time in Aubrey Terrace, near its junction with Broadway. It was agreed that this item should be placed on the agenda for the next Planning Meeting.
